Mileage Commodity Rates Via All Surface Motor Routes Between Points in North America (Except Mexico) Applying on:

- Transport of commodities requiring temperature-controlled equipment, where the entire shipment moves exclusively and entirely via Carrier's White Glove Services division. Provides exclusive-use, door-to-door delivery, with full-range temperature control. Shipments are monitored 24/7 and cargo hold temperatures are recorded during transport with a data receipt provided after each shipment. This validated service is supported by a dedicated Quality Assurance Team and the FedEx Custom Critical Quality Management System.

This publication will not apply on shipments for which service is requested, required, and/or provided, in conjunction with or in whole or in part, by FedEx Custom Critical, Inc.'s Surface Expedite Exclusive Use service or any other services other than exclusive-use expedited surface transportation provided solely, entirely, and exclusively via FedEx Custom Critical, Inc.'s Exclusive Use White Glove Services.

Item 10: Application of Rates and Operating Rights

Rates and provisions named in this publication, or as amended, are limited in their application on interstate, intrastate and/or foreign commerce to the extent of the operating authority of FedEx Custom Critical, Inc. All surface transportation provided is over irregular routes.

Shipments will be categorized in accordance with the Rate Category applicable for each shipment. Shipments requiring larger equipment than those associated with each Rate Category, due to dimensional characteristics of the cargo, will be rated utilizing the necessary Dimensional Category needed to accommodate the dimensional characteristics. Specifications are as follows:

Rate Category	Weight Capacity	Vehicle Size	Dock High
B	Up to,500 lbs.	Typically a cargo van	No
C	Up to 5,000 lbs.	Typically a 12' or 14' straight truck	Yes
D	Up to 13,000 lbs.	Typically a 20' or 22' straight truck	Yes
E	More than 13,000 lbs.	Typically a tractor with a 48' or 53' trailer	Yes

Due to the weights of extra equipment temperature-control trucks are required to carry, these vehicles may not be able to meet the weight capacities listed above.

Note: When dock high equipment is requested or required, pricing for dock high equipment will apply even when shipment characteristics would have been satisfied by a smaller vehicle type.

Item 40: Application of this Publication

a) Temperature-Controlled Validated Service

b) The rate and provisions of this tariff will only apply when the specialized handling service offered by the White Glove Services Division of FedEx Custom Critical, Inc. is requested and/or furnished.

Item 120: Pickup and Delivery Service

Rates published in this publication, include as to each shipment, one pickup at point of origin within the limits of the cities, towns or villages from, to or between which the rates apply and one delivery at point of destination within the limits of the cities, towns or villages from, to or between which the rates apply.

Item 130: Standard "Care in Handling" Equipment

(a) Shipments transported in White Glove Services vehicles typically will have the following Standard "Care In Handling" Equipment:

(b) When additional equipment is requested or required, the charge for such equipment shall be the actual cost plus 30%. Items that must travel with the shipment will be subject to a minimum charge of one calendar week or calculated time for a round-trip run, whichever is greater.

Item 300: Charges In Straight Or Mixed Shipments For: (Additionally subject to the provisions of Item 575 of Service Guide Tariff FDCC 101)

- Temperature-Controlled Validated Service

Subject to legal load limits, shipments will be rated in accordance with the Rate Category. Shipments requiring larger equipment than those associated with each Rate Category, due to dimensional characteristics of the cargo, will be rated in accordance with the necessary Dimensional Category. When dock high equipment is requested or required, pricing for dock high equipment will apply even when shipment characteristics would have been satisfied by a non-dock high vehicle.

Note 1: If a certain weight capacity, dimensional capacity or equipment type is requested which is NOT available, FedEx Custom Critical will provide for weight capacity, dimensional capacity or equipment type of greater capacity with charges calculated and based upon those applicable for those requested, unless, upon arrival at the shipper location, it is determined that the requested weight capacity, dimensional capacity or equipment type was inadequate for the purposes of transporting the shipment, charges will be re-assessed based upon those applicable for the weight, dimensional characteristics or vehicle type provided, whichever is greater.

Note 2: When required to provide power to transport a customer trailer, a charge equal to 50% of the base mileage rate will additionally apply as a tractor repositioning charge.
